Martin Johnston Saunders

Age 70, of Fox Chapel, passed to eternal life on November 2, 2019.

Son of the late Norval Saunders and Jane Johnston Saunders. Born and raised in Cincinnati, Marty came to Pittsburgh in 1974 when he joined Westinghouse as labor counsel following graduation from New York University with an LL.M. in labor law. Survived by his wife of 34 years, Rosanne Clementi Saunders; and children, Martin R. (Juliane Berg) and Clare A. The family is grateful to everyone who supported Marty after he was diagnosed with ALS in 2018, particularly the staff of the Western Pennsylvania Chapter of the ALS Association and the ALS Clinic at Allegheny General Hospital. Marty practiced management labor and employment law for over forty years. He finished his long and distinguished legal career by opening Steptoe and Johnson's labor practice in Pennsylvania. Considered by his Steptoe peers to be an authority on the legal community in Western Pennsylvania, Marty was regularly recognized by Best Lawyers in America and was known as a generous mentor to younger lawyers.
